Since May 2025, STRACK NORMA has been operating under a court-approved protective shield procedure. Unlike traditional insolvency, this is a voluntary restructuring process. Approval is granted only if a company is healthy and liquid but wants to proactively safeguard against potential risks. "We acted consciously and responsibly," says Managing Director Michael Lang. The goal is to strengthen structures and prevent any risk of insolvency from arising in the first place.

## **Investing in Future Viability**

In recent months, the family-owned company from Lüdenscheid has strategically laid the foundation for further growth. Investments have been made in modern infrastructure, optimized supply and production processes, and employee upskilling. All jobs have been fully preserved—no economic layoffs or short-time work were necessary. The Managing Director himself is also sending a strong signal: Michael Lang recently reached an agreement with the former shareholders to personally invest in the company and acquire shares—a clear sign of long-term commitment and entrepreneurial responsibility.

## **Reliable Supply and Strategic Security**

Warehouses are well stocked, supply chains remain intact, and customers can continue to rely on on-time deliveries and the usual high quality. "For our customers and partners, nothing changes. We remain fully capable of delivery—today, tomorrow, and beyond," emphasizes Lang.
